Please note in order to recover full costs incurred, we hereby give notice that our THC charge for hazardous cargo will be increased to the below levels effective for shipment sailing / arriving on or after the 21<sup>st</sup> April 2010. Please note our THC charge for export and import non-haz shipment remains unchanged.
